1. The candidate should be present at the examination venue 30 MINUTES BEFORE THE SCHEDULE of examination.
2. Electronic Items, Mobile Phones, Calculators etc. are NOT allowed inside the Examination Hall.

Please note the following:

1. You are required to appear for the Written Test on the date and venue indicated overleaf.
2. The posts are reserved for **ONE LEG Affected (OLA) or ONE ARM Affected (OAA)** under Orthopaedically Handicapped (OH) Category and for persons falling under Hearing Handicapped (III) Category. Any other kinds of disability shall be a disqualification. Such candidates may voluntarily desist from appearing in the Examination.
3. Answer of the questions needs to be recorded on OMR Sheet. **ONLY ONE** OMR Sheet will be given for marking the answers. Candidates are requested to read and understand all the instructions written on the OMR sheet before marking the answers. OMR sheet should not be folded or crushed. **Using of blue/black ball pen is only permitted.** Candidates should bring the blue/black ball pen. Usage of ink/gel pen/pencil is not allowed and strictly prohibited. Rough work is not allowed in OMR sheet.
4. Candidates who qualify in the Written Test will have to appear for Interview. The date of Interview will be intimated later.

You are required to bring this Admit Card cum Call Letter in original duly affixing your latest photograph duly attested on it by a :

- a. Gazetted Officer of Central or State Government **OR**
- b. Tehsildars or Naib / Deputy Tehsildars authorised to exercise magisterial powers **OR**
- c. Principal / Head Master of the recognised School/College/Institution where the candidate studied last.

Please note that those who are coming w/o photograph and attested on it will not be allowed to write the Examination.

Candidates should make their own arrangements to stay at Mumbai. The date fixed for the Written Test cannot be changed under any circumstances.
