**NOTIFICATION**

The Gauhati High Court has been pleased to notify that the **Written Examination (Objective Type Questions with Multiple Choices) of 100 (One hundred) marks** for direct recruitment to 15(Fifteen) posts of **UDC** for the subordinate courts of Arunachal Pradesh will be held as per the Schedule of Examination indicated below.

It is notified that Gauhati High Court has decided to hold separate examination for each of the posts indicated in the advertisement dated 18-7-2013 since, in terms of Clause 8(i) of the advertisement, candidates were directed to submit separate application for separate post.

It is further notified that all candidates who have been included in the list, published in the website, are provisionally allowed to appear in the examination. The candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 18-7-2013. No T.A/D.A will be paid to the candidates for appearing in the written examination.

Any objection/clarification etc. in respect of the list of candidates shall be brought to the notice of the Joint Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh on or before 3-1-2015 during office hours.

**Admit cards are being issued to the candidates by post. If any candidate does not receive the same on or before 21-1-2015, he/she can collect the same in person from Joint Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh on 22-1-2015 during office hours.**

Allowing the candidates to appear in the written examination does not necessarily mean acceptance of their candidatures which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage on detection of any ineligibility condition.


